



## OHHealthJobs.net Terms and Conditions

This agreement sets out the terms agreed to between OHA Solutions, a subsidiary of the Ohio Hospital Association ("Association") and the undersigned \_\_\_\_\_ ("Subscriber"), under which the Subscriber may participate in an Internet job listing and search Web site "OHHealthJobs.net." Participating Subscribers can use the Web site to post healthcare job listings and opportunities, and candidates may search those listings for healthcare job opportunities in the State of Ohio. Use of OHHealthJobs.net constitutes acceptance of the Terms and Conditions by Subscriber.

Term and Termination: June 1, 2010 through May 31, 2011. This agreement shall automatically renew for successive one (1) year terms unless otherwise terminated by either party as provided by this agreement. Either party may terminate this agreement upon thirty (30) days prior written notice to the other party, or immediately upon any breach by the other party.

Fees: Subscriber agrees to pay the relevant annual fees as set forth in the section of this agreement entitled "Subscription Fee and Billing Information." OHA Solutions shall invoice Subscriber for the fees, and Subscriber shall pay such fees within thirty (30) days. The fees described in this Agreement are non-refundable. OHA Solutions may terminate this agreement in its discretion for nonpayment of fees.

Materials: OHA Solutions provides a tool for Subscriber's recruitment efforts. The OHHealthJobs.net site is a resource available to institutions that are eligible for membership in the Association that attracts job seekers from Ohio and across the nation wanting to obtain information regarding Ohio healthcare opportunities.

Use of Information: Job postings for an individual hospital shall only be permitted if that hospital is a Subscriber. Subscriber shall be responsible for the accuracy, timeliness, completeness, legality, and removal of its advertising and may add, delete or edit information relating to its own hospital job postings and positions, but not to those of any other hospital or participant in the Web site.
